## Hospital Standardised Mortality Ratios

### Quarterly HSMR Release


### About this Release

Since December 2009 Information Services Division (ISD) has produced quarterly hospital standardised mortality ratios (HSMR) for all Scottish hospitals participating in the Scottish Patient Safety Programme (SPSP). HSMRs are calculated when crude mortality data are adjusted to take account of some of the factors known to affect the underlying risk of death. The intention is to allow monitoring of time trends in mortality for Scotland and at individual hospital level. The aim of the Scottish Patient Safety Programme is to reduce hospital mortality by 15% by December 2012. This will then be extended to a 20% reduction by December 2015.

### Key Points

- HSMR at Scotland-level has decreased by 12.4% between October to December 2007 and July to September 2012.
- Twenty seven (87%) of the thirty one hospitals participating in the SPSP have shown a reduction in HSMR since October to December 2007 (end of the baseline year).
- HSMRs in Scotland are not directly comparable to similar measures adopted elsewhere in the United Kingdom.

## Background

The HSMR is based on all acute inpatient and day case patients admitted to all specialties (medical and surgical). The calculation takes account of patients who died within 30 days from admission; that is, it includes deaths that occurred in the community (out of hospital deaths) as well as those occurring in-hospital.

### **Hospital Standardised Mortality Ratio (HSMR) = Observed Deaths / Predicted Deaths**

The Scottish HSMR for July to September 2012 is currently 0.87, a decrease of 13% from the baseline year (October 2006 to September 2007) value of 1.00. Regression analysis for Scotland indicates that by July to September 2012, cumulatively, there had been a 12.4% reduction in hospital mortality since October to December 2007.

As is routine, some elements of the analysis was previously released to NHS Boards on Friday 1<sup>st</sup> February as management information. This follows a systematic review of the data, which has been carried out by representatives from Information Services Division and Healthcare Improvement Scotland. The purpose of the review is to identify potential patterns in the data and to initiate a dialogue with boards where appropriate. As the emphasis remains on local ownership of the data, a [guidance document](#) has been prepared jointly by Healthcare Improvement Scotland, the Information Services Division, Scottish Patient Safety Programme, and the Quality Improvement Hub.
