

Allied Health Professionals – Musculoskeletal Waiting Times in NHS Scotland

About this release


This publication by Information Services Division (ISD) presents information on how long patients wait for Musculoskeletal (MSK) services that are delivered by Allied Health Professionals (AHP). This publication includes waiting times information for nine NHS Boards.

Main Points

In the quarter ending March 2016 for AHP MSK services (Physiotherapy, Occupational Therapy, Chiropody/Podiatry and Orthotics) in the nine NHS Boards:

- 62,425 patients had a first clinical appointment with an AHP MSK service (all professions) and just over half (50.3%) were seen within 4 weeks. This compares with 49.2% during the quarter ending December 2015.
- Nine out of ten patients were seen within 17 weeks.

Background

The term musculoskeletal (MSK) problems includes a diversity of complaints and diseases localised in joints, bones, cartilage, ligaments, tendons, tendon sheaths, bursa and muscles. MSK problems also include outpatient pre or post orthopaedic surgery, peripheral nerve lesions (e.g. carpal tunnel, sciatica) or complication of fracture/dislocation/trauma.

The Scottish Government has determined that the AHP MSK waiting times target should be delivered for at least 90% of patients, as for some patients it may not be clinically appropriate for treatment to begin within the 4 week target time.

The target that 90% of eligible patients will receive a first clinical out-patient appointment within 4 weeks by 1 April 2016 is measured by the percentage of patients who attended first clinical out-patient appointment for an AHP MSK service within 4 weeks of receipt of referral from a patient or health or social care professional. In line with the [NHSScotland Waiting Times Guidance](#) adjustments and clock resets are only made up to the target point of 4 weeks. The target should be met by each profession individually within each Board.

The nine NHS Boards providing AHP MSK data are; NHS Ayrshire & Arran, NHS Borders, NHS Dumfries & Galloway, NHS Forth Valley, NHS Grampian, NHS Greater Glasgow & Clyde, NHS Lanarkshire, NHS Lothian and NHS Western Isles. Once all NHS Boards IT systems have been fully developed the data that will be reported will include data for the remaining five NHS Boards and the missing professions. A minimum dataset has been developed to support MSK redesign and transformation. Collection of an MSK information dataset identifies 4 week achievement and audit performance against the MSK Minimum Standards.
