

# Publication Summary



## Child & Adolescent Mental Health Services in NHS Scotland

Workforce Information as at 31<sup>st</sup> March 2014

27<sup>th</sup> May 2014



### About this Release

This release is a collaborative piece of work between ISD and NHS Education for Scotland (NES), and presents Child & Adolescent Mental Health Services (CAMHS) workforce information on staff in post as at 31<sup>st</sup> March 2014.

The data are presented as figures in both Headcount numbers and Whole Time Equivalents (wte). Wte's adjust headcount staff figures to take account of part-time staff

### Key Points

- In 2009, the Scottish Government committed central funding to expand the CAMHS workforce of NHSScotland.
- Since 30<sup>th</sup> September 2009 the CAMHS workforce in NHSScotland has risen from 764.6 wte (883 headcount) to 917.5 wte (1075 headcount) as at 31<sup>st</sup> March 2014.
- The staff groups with the most significant increases are Psychology (143.8 wte in 2009 to the current 237.3wte; a 65.0% increase), and Nursing (320.4 wte in 2009 to the current 369.2.0 wte; a 15.2% increase).
- The current headcount of 1075 clinical staff (917.5 wte) as at 31<sup>st</sup> March 2014 is an increase of 0.8% (0.9% headcount) in staff in post wte since 31<sup>st</sup> December 2013. From the 31<sup>st</sup> March 2013 it is a decrease of 0.5% wte (-0.6% headcount).
- Nationally, this represents a staffing level of 17.3 wte clinical workers per 100,000 of the population of Scotland.
- As at 31<sup>st</sup> March 2014, an additional 45.8 wte posts throughout NHS Scotland CAMHS were between being advertised and being filled. A further 10.4 wte posts were approved for recruitment but not yet advertised.

### Background

[The Scottish Needs Assessment Programme \(SNAP\) Report](#) on Child and Adolescent Mental Health highlighted the importance of Child and Adolescent Mental Health Services (CAMHS) and the need for development of these services within Scotland. In October 2005, the Scottish Executive (Government) published [The Mental Health of Children and Young People: A Framework for Promotion, Prevention and Care](#) which set the policy direction and a commitment to developing these services.

Delivery of good quality CAMH services depends on adequate numbers of well trained staff being available for career posts in services across NHSScotland.

Data on the staff in post in NHSScotland CAMHS services have been reported since 2006.

CAMH Services vary across Scotland and the definition includes the following service types:

- Multi-disciplinary CAMHS, including clinical psychology
- Multi-disciplinary CAMHS, excluding clinical psychology
- Psychology services in Child Health/Paediatrics
- Island services – provided by two or three professionals
